It was identified during the February SLIGP Quarterly Review Call that Michigan had misunderstood the allowable match requirements and has been incorrectly reporting these figures. The matching funds reported in the "other" category is higher than projected due to the State now reporting Workgroup Member's salary as match. Also, Michigan voluntarily de-obligated \$300,000 and the amended budget was approved in July 2017. Corrective entries for the match reporting and the amended budget are reflected in this report.

11d. Describe any success stories or best practices you have identified. Please be as specific as possible.

During this reporting period, the State Plan Review Team finalized its review and comparative analysis of the FirstNet State Plan and alternate proposals. Governor Snyder accepted the Review Team's recommendation to opt-in to FirstNet's proposal for the buildout of the Nationwide Public Safety Broadband Network in Michigan, and a Letter of Affirmation was submitted by the Governor's office to First Net on August 4, 2017. Production of the MiPSB Program's video was completed and has been used during conference presentations and webinars. It is hosted on the MiPSB website (www.michigan.gov/mipsb) and links to the video have been posted on Twitter and included in correspondence. Michigan, AT&T, and FirstNet hold weekly conference calls to maintain an open dialogue, as well as meeting to discuss centralized policies and procedures, and network design to support critical infrastructure. Michigan and AT&T are in negotiations for a contract change notice to the NASPO contract to provide discounted rates and structured packages for State and local agencies to procure FirstNet services.
