#### **Call to Order**

The meeting commenced with brief comments by Commerce Secretary Penny Pritzker. Following those comments, Chairman Sam Ginn called the meeting to order and a quorum of board members was present.

#### **Board Resolutions**

The board considered and approved five resolutions. The resolutions were as follows:

 Resolution in which the FirstNet Board extended its formal appreciation to William Keever for his extraordinary service and dedication as a member of FirstNet's inaugural Board, and respect his decision not to remain as a FirstNet Board member going forward. (FirstNet Resolution 38) was adopted by unanimous vote.

- Resolution in which the Board extended its formal appreciation to Jeffrey Johnson for his
  extraordinary service and dedication as FirstNet's Acting User Advocacy Officer. . The
  Board also expressed its thanks to Sue Swenson for her tireless effort and dedication
  while leading FirstNet's BTOP negotiations and licensee spectrum management duties.
  The Board also acknowledged that Craig Farrill intends to return to his traditional Board
  Member role as soon as FirstNet hires a Chief Technical Officer. (FirstNet Resolution
  39) was adopted by unanimous vote.
- Resolution renaming the State, Regional, Local, and Tribal Consultation Committee as the User Outreach Committee.
- Resolution to extend its period for negotiations on spectrum lease agreements with the State of Mississippi and the Bay Area Regional Interoperable Communications System Authority through September 30, 2013, and authorizes FirstNet's Deputy General Manager, TJ Kennedy, to continue such negotiations on FirstNet's behalf. (Resolution 41) was adopted by unanimous vote.
- Resolution establishing the \$194,000,000.00 budget, on an obligations basis, recommended by the General Manager as the Budget of FirstNet for its Fiscal Year 2014. (FirstNet Resolution 42) was adopted by unanimous vote.
