Describe your progress meeting each major activity/milestone approved in the Baseline Report for this project; any challenges or obstacles encountered and mitigation strategies you have employed; planned major activities for the next quarter; and any additional project milestones or information.

Stakeholder Meetings: Although ECN has met with the public safety personnel from each tribal nation as part of the coverage county assessment, this quarter we decided to host a regional tribal meeting with the Sioux tribes and invite FirstNet. Our eleven tribes fall into three main tribal nations—Sioux, Red Lake and Chippewa tribes. We will continue to reach out to the other two regions to host a regional tribal meeting with FirstNet tribal government liasions. Throughout this quarter ECN met with every PSAP agency and their GIS

representative to review each of their public safety agency's boundaries and put this into a coordinate database (GIS) for FirstNet. ECN met with each agency a second time to review the data after it was put into a GIS map.

**Training:** Nothing additional developed during this reporting period. A great deal of training occurred during the Phased Buildout presentations helping everyone understand the various methodologies that could be adopted as well as a thorough review of the recommendations provided to FirstNet for the Phase 2 data delivery.

Staff Hires: 0 During the period.

Contract Executions: None during this reporting period.

Governance Meetings: Monthly meetings of Statewide Emergency Communications Board (SECB) and its various committees and working groups, monthly meetings of SECB Interoperable Data Committee.

Education and Outreach materials: Website contains the Phase 2 material summary presentation as well as the responses to all FirstNet Public Notices. Working on a FirstNet and NG911 training module as well as a detailed LTE technical training module.

Phase 2 Activities:

Coverage: Analysis completed and presented to FirstNet on Sept. 30th.

Capacity Planning: Information has been collected from the workgroup and uploaded to FirstNet.

State Plan Decision: Outline completed. Met with Governor's staff and Commissioner's office. Waiting for next steps requested of FirstNet.

Completed and submitted all Phase 2 data collection requirements with Sept 30th deadline. Updating some data as it comes in from agencies that were slow to provide it.

ECN has met with the 11 tribal nation's public safety agencies through the Coverage Assessment process however, this quarter we also hosted a regional tribal meeting with all the members of the Sioux nation (Mdewakanton, Upper, Lower, and Pine Island nations) and the FirstNet tribal government liaisons, Carl Rebstock and Adam Geroler. In addition to inviting back the public safety contacts we met with initially, ECN invited tribal leaders, IT, legal and emergency management as well to broaden the contacts within the Sioux Tribe. This meeting went very well. ECN, FirstNet and the tribal representatives had an opportunity to ask each other more questions, get a better understanding of each other's concerns and fears. We have scheduled the second major tribal nation, the Chippewa Tribe, for January, 2016 with a request to Red Lake Nation also.
