**New Jersey Office of Homeland Security and Preparedness
State and Local Implementation Grant Program (SLIGP) 2.0
Application Narrative**

I. Letter of Designation

Each State is required to certify in its application for grant funds that the State has designated a single officer or governmental body to serve as the coordinator of implementation of the SLIGP grant funds. As noted in Governor Chris Christie's December 1, 2017 letter (uploaded as an attachment into Grants.Gov), Eric Tysarczyk was reaffirmed as New Jersey's Single Point of Contact for the implementation and coordination of SLIGP 2.0 grant funds.

II. Proposed Activities

The State of New Jersey, through its Office of Homeland Security and Preparedness (NJOHSP) possesses the capacity and qualifications, knowledge and experience necessary to successfully implement SLIGP 2.0. The proposed project plan entails the following activities:

- Deliver up to three (3) regional workshops with one targeted to law enforcement, one to fire, and one to emergency medical services/911 centers that are focused on presenting information about and promoting the use of an IP-based communication network like FirstNet.
- Undertake a Public Safety Answering Point (PSAP) phase 2 project that will outline plans, steps and strategies PSAPs should follow to integrate their PSAPs with FirstNet and the State of New Jersey's planned statewide Emergency Services Internet Protocol (IP) Network (ESINet).
- Conduct planning activities centered on technology transitions
- Contracting an ICB grant manager for SLIGP 2.0 program, project, and financial management support.
- The ICB and FirstNet Regional Lead David Cook will present outreach and education awareness sessions about the Nationwide Public Safety Broadband Network (NPSBN) at various associations, conferences, and meetings within New Jersey. Note: this activity will be performed as needed based on future scheduling of such sessions by the respective host agencies. The timing and location of these sessions is not currently known. SLIGP 2.0 expenditures are not anticipated to be incurred for this activity.

III. Deliverables

Deliverable #1: Deliver up to three regional workshops with one targeted to law enforcement, one to fire, and one to EMS/PSAPs, where the ICB partners with FirstNet to present information about and to promote the use of an IP-based communication network like the Nationwide Public Safety Broadband Network. These workshops will be conducted at the request of FirstNet and will not involve the operation of a demonstration network.

Objective

To familiarize first responders with the application of broadband wireless technology in a manner that improves the safety of both public safety personnel as well as the public, increases productivity, and provides improved access to and interpretation of data that enhances emergency responses. The ICB will evaluate attendees' feedback at the completion of each of workshop to determine the level of first responders' understanding of how the NPSBN can improve their safety, productivity and access to data.

Organization and Content

The workshops will be centered on three public safety service sectors with one targeted to law enforcement, one to fire, and one to emergency medical services/public safety access points. These service focused workshops will devote full attention to the three sectors with content exclusively focused on each. The benefit of a service focus is that the content may be of more interest to an audience with common interests. FirstNet Regional Lead David Cook has been involved in the early discussions of these proposed targeted regional workshops and has approved the approach and delivery of the sessions. These workshops are being conducted at the request of FirstNet.

The following comprises fundamental content that will be provided at all three workshops:

- Brief overview of FirstNet deployment in New Jersey
- What is Next Generation 911 (NG911) and an ESInet
- An overview of the purpose of NG911
- Convergence of FirstNet and NG911
- How this Convergence is Realized

The ICB will ensure that each of the three workshops will include demonstrable scenarios and use cases that will resonate with first responders and non-technical public safety officials. To help achieve this objective the following content specific information will be delivered using live enactment scenarios and discussions of use cases at the respective public safety services sector:

Law Enforcement - *A Day in the life of a patrol officer*

Fire - *A Day in the life of a firefighter*

Emergency Medical Services - *A Day in the life of an EMT*

Action Steps

- NJOHSP to contract Mission Critical Partners (MCP) to provide the necessary programmatic and administrative support to deliver up to three regional workshops.
- MCP to identify potential site venues, facilitate site selections, distribute "hold the date" notifications, manage invitation process, prepare and copy all necessary presentation and supporting materials, fully develop scripts and use cases for the live enactment scenarios, and create an online video file containing the information and presentations from the workshops.
- One regional workshop is currently proposed to be held during the first nine months (year one) of the SLIGP 2.0 period of performance and up to two additional regional workshops will be held

during the final 15 months (year two) of the period of performance. FirstNet Regional Lead David Cook will participate in each of the workshops schedule permitting.

- MCP will conduct weekly update conference calls and dashboard status sessions with ICB.

Deliverable #2: Develop and outline strategies PSAPs should follow to integrate their PSAP with FirstNet and the State of New Jersey's planned statewide ESInet.

Background

Under SLIGP, the ICB assessed PSAP readiness for FirstNet's Nationwide Public Safety Broadband Network. A representative sample of 13 urban, suburban and rural PSAPs were visited and surveyed over a three-month period. The purpose was to gain an understanding of the challenges faced in implementation of NG911, and the integration of such systems with the NPSBN, as well as to measure the level of interest and proposed uses of the NPSBN as it is deployed throughout New Jersey. PSAP administrators were asked to share their concerns and perceived challenges of integrating of FirstNet into their 911 operations.

Assessment data indicated a variety of challenges are prevalent among the PSAPs interviewed including:

- **Funding:** Capital and operating budget constraints currently do not permit investment in technology that would improve the effectiveness and efficiency of public safety operations.
- **Staffing:** Longstanding personnel constraints affect daily operations and reduce the ability of agencies to take on new projects.
- **Network:** Delay in deploying a statewide ESInet, an entry-level requirement for NG911, is one roadblock to providing a 911 caller's multimedia data, such as video and images, to field responders.
- **Automated Systems:** Many PSAPs today maintain legacy phone and computer-aided dispatch (CAD) systems that are incapable of receiving, storing, or distributing NG911 data, including multimedia data.
- **Data Analysis:** With the influx of large amounts of data, there is an apparent need for situational awareness centers (SAC), either co-located with PSAPs or housed elsewhere, that are staffed with trained personnel that can monitor and analyze new and rich types of data, such as video/images received from the public, security and traffic cameras feeds, automated sensors, and first responder data. Lack of funding is a primary issue to implementing SACs; however, the role played by SACs would provide improvements in safety for both the public as well as for first responders.

Objective

NJOHSP will conduct planning activities under SLIGP 2.0 to prepare for emergency communications technology transitions. Activities will identify and plan for the transition of public safety applications, software, and databases used by a small number (up to 5) local and state PSAPs that are interested in planning for the convergence of NG911 technology and services, dispatch system and FirstNet's NPSBN.

For the purposes of the SLIGP 2.0 project, use of FirstNet by PSAPs is considered as providing basic or advanced functions. Certain PSAPs in New Jersey will be selected for detailed study regarding the steps that would need to be taken to provide the most basic use of FirstNet (database inquiries, field reporting, access to computer aided dispatch and records management applications, messaging, and location information (mapping, directions and/or routing). Basic functions may already be provided by other

wireless networks and interfaces, and are the first step toward more advanced applications. Advanced applications include live streaming of body camera video, dash cam and in car video, videoconferencing (particularly in EMS applications), interoperability with Land Mobile Radio (LMR) systems, automatic license plate reader systems, Internet of Things (IoT), and other capabilities that will be transitioned to the NPSBN.

Action Steps

- Create a planning document, outlining the specific steps, timeline, and task deliverables.
- Identify the technology, operational, and policy needs of PSAPs and first responders pertaining to PSAP and NPSBN integration, using a mix of interviews, assessment, and a needs analysis.
- Develop a model of the integration steps, policies, and costs (not a detailed cost study).
- MCP will conduct weekly update conference calls and dashboard status sessions with ICB.

Advanced Service Integration

Identify the technology and processes required to enable the capture, distribution, display, and archival of text, images, and video content between the 911 caller, telephone customer premises equipment, and CAD systems at the PSAP, and with mobile equipment used by responders.

When NG911- is implemented, examples of multimedia data that could be shared include:

- Multimedia data from 911 callers
- Field-originated video, such as from responder body or dashboard cameras
- Video from public or private CCTV or surveillance cameras
- Data received from sensors or other automated systems

Action Steps:

- Create a planning document, outlining the specific steps, timeline, and task deliverables.
- Develop a user level description of the application of the NPSBPN with NG911 and PSAP systems under various operational scenarios.
- Gather requirements from the 911 and responder communities to identify the stakeholders' specific needs for integrating these systems.
- Based on stakeholder input, determine the technical, operational, policy, and staffing requirements to implement the advanced service integration.
- MCP to conduct weekly update conference calls and dashboard status sessions with ICB.

Deliverable #3: *Provide public safety agencies within New Jersey with technology transition planning support. Perform continuing assessments of the coverage provided by the NPSBN in New Jersey and provide input to FirstNet and its contractor, AT&T, regarding gaps and unmet user needs.*

Allowable Activities - Opt-In States

Among the SLIGP 2.0 allowable activities for states where FirstNet is deploying the RAN (Opt-in States) are planning activities to help FirstNet and its partner further identify potential public safety users of the NPSBN. These activities can include:

- Planning activities to prepare for emergency communications technology transitions.
- Activities to identify and plan for the transition of public safety applications, software and databases.
- Identifying and documenting on-going coverage gaps/needs within the State.

Objective

The primary objective of the technology transition and coverage gaps/needs planning is to provide support to public safety entities in New Jersey to prepare for the convergence and transition of public safety communications from legacy technology to the next generation of wireless and information technology. A second objective is to provide liaison between NJOHSP, FirstNet and AT&T in the identification and resolution of coverage gaps in the planned and deployed NPSBN that would affect its adoption and integration into public safety operations in the state.

Mission Critical Push to Talk Operation

The foundation of daily public safety tactical operations is mission critical push to talk (MCPTT) voice communications. These communications, largely provided on private land mobile radio systems (LMR) operated by states, counties, and municipalities, will continue to be the mainstay of public safety operations. FirstNet has the potential to be a disrupter of the status quo of MCPTT on LMR.

Technology Transition Planning Activities Proposed

MCPTT is a key variable in the uptake of FirstNet services in the future. While the NPSBN provides spectral and interface standards, MCPTT is evolving and there is the probability of incompatibilities between users that will negatively affect interoperability unless planning commences immediately. During the SLIGP 2.0 two-year period of performance, NJOHSP will contract Mission Critical Partners (MCP) to provide:

- Ongoing planning and information sharing regarding the use of FirstNet's NPSBN to improve interoperability between traditional LMR systems and public safety entities in New Jersey. Planning activities include:
 - Standards progress - MCP will monitor, track, and share progress of 3GPP standards releases related to MCPTT and product development at the user level that will facilitate adoption of the service.
 - AT&T progress in implementation of MCPTT by the March 2020 goal of FirstNet - MCP will maintain liaison with AT&T related to their implementation of standards based MCPTT on the NPSBN.
 - MCP will work to identify methods for provision of interfaces between typical PSAP console systems and the NPSBN, through the use of standards based methods, such as Inter RF Subsystem Interface (ISSI) or Console Subsystem Interface (CSSI) to provide talkgroup control and logging recorder interfaces. These interfaces will not be specific to particular PSAP's.

MCP will assess and identify applicable FirstNet approved/certified applications for NJOHSP.

- Activities to identify and plan for the transition of public safety applications, software and databases.
 - Analysis will be performed on legacy public safety applications in use by public safety entities to determine the feasibility of transition to FirstNet.
 - Review of applications that may become available through FirstNet for transition of existing functions of public safety entities in the state, including for NJOHSP.
 - Identification of databases that may be accessed by public safety entities through a FirstNet interface.
 - Assess changes to processes that may be accommodate by public safety applications that can be interfaced with FirstNet.
- Readiness of FirstNet to provide MCPTT service at public safety grade
 - Policy guidance is needed to determine when FirstNet's MCPTT meets public safety grade.
 - The National Public Safety Telecommunications Council (NPSTC) is currently drafting MCPTT public safety grade service recommendations that will need to be reviewed. MCP will provide a review and assessment of NPSTC's draft recommendation and prepare comments to NJOHSP so that it can establish a position on this service as applied to New Jersey's needs.
- Interoperability between LMR systems and the NPSBN
 - With the advent of FirstNet MCPTT services, interfaces with traditional land mobile radio systems are needed to maintain interoperability for tactical operations.
 - Planning for these interfaces is needed to incorporate into emergency response plans. Standardized nomenclature, mutual aid talkgroups, and activation processes will be needed to prevent incompatibilities that may arise in response to an emergency event in New Jersey or in another state. MCP will provide ongoing planning support to NJOHSP and OIT.
- NPSBN interfaces for public safety Internet of Things (IoT) devices
 - FirstNet's partner, AT&T, has advised that consumer grade IoT devices will not be supported on FirstNet. Other, more secure devices, for public safety use, will be supported for video surveillance, vehicle tracking, fire alarm sensors, and other applications. MCP will provide planning support to prepare for the transition of IoT devices used by New Jersey public safety organizations.

Coverage Gaps/Needs Planning Activities Proposed

- Mission Critical Partners will continue to provide planning support to the ICB as part of the deployment of the NPSBN in New Jersey. This includes planning support as part of all network buildout planning group sessions that includes representation from FirstNet,

AT&T, NJOHSP, OIT, State Police, as well as local units of government and university representation. The MCP will maintain contact with the county offices of emergency management (OEM) coordinators, providing input on the location and timing of additional NPSBN site builds for coverage and capacity purposes, follow AT&T network deployment progress (IOC-2 and IOC-3) with regular reporting to NJOHSP, and provide ongoing information to New Jersey public safety organizations through the county OEM coordinators with progress report emails.

- NJOHSP proposes to acquire smartphone-based measurement software and support to permit drive testing and indoor coverage verification that reflects the user experience. This software will operate on compatible, commercial off-the-shelf, smartphones that will operate on the NPSBN and the AT&T commercial network. A software package that permits sharing of measurement files with AT&T will be selected. Use of the software and devices will be by NJOHSP, its consultants, and/or other state and local units of government. Timing of the software purchase is affected by the completion of IOC-1 of the deployment of FirstNet Band 14. The measurement activity will not commence until early 2019 at which time meaningful deployment of Band 14 coverage in New Jersey will be underway or completed. The measurement system will provide insight to the performance of the AT&T commercial network in addition to Band 14, as the two networks will be tightly integrated into public safety operations. No drive testing equipment is to be purchased with SLIGP 2.0 funds.

Action Steps

- Develop a guidance document for public safety entities that will describe a standards based approach to interoperability between LMR and FirstNet MCPTT.
- Prepare comments to NPSTC and participate in their process of evaluating the readiness of FirstNet to provide public safety grade MCPTT service.
- Prepare an assessment of the application and effect of IoT devices on the NPSBN, their use in improvement of situational awareness, tactical and surveillance operations of EMS, fire and law enforcement.
- Perform continuing assessments of the coverage provided by the NPSBN in New Jersey and provide input to FirstNet and its partner contractor regarding gaps and unmet user needs utilizing the smartphone-based measurement software purchased under SLIGP 2.0.

IV. Capacity to Manage and Conduct Programmatic Activities

This section details the capacity and qualifications of the New Jersey Office of Homeland Security and Preparedness to successfully manage and conduct programmatic activities of the SLIGP 2.0 award and ability to adhere to National Telecommunications and Information Administration (NTIA) grant reporting and compliance requirements described in section F.3 of the Notice of Funding Opportunity.

NJOHSP leads and coordinates New Jersey's counterterrorism, cybersecurity, and emergency preparedness efforts while building resiliency throughout the state. NJOHSP's Interoperable Communications Bureau currently administers the SLIGP grant program on behalf of the State of New Jersey. NJOHSP was designated by Governor Chris Christie on May 13, 2014 to serve as governmental body to be responsible for implementing SLIGP grant funding. On March 1, 2017, NJOHSP's former Director Chris Rodriguez

designated Eric Tysarczyk, Director of NJOHSP's Policy and Preparedness Division as New Jersey's Single Point of Contact (SPOC) for the coordination and implementation of SLIGP and associated activities of the Nationwide Public Safety Broadband Network. As noted above in Section I, on December 1, 2017, Governor Chris Christie reaffirmed Division Director Eric Tysarczyk as the SPOC for the coordination and implementation of SLIGP 2.0 grant funds. The Interoperable Communication Bureau reports to Division Director Tysarczyk.

As the SLIGP 2.0 applicant, NJOHSP will provide grant management, financial management, project management, and public safety coordination and information sharing. NJOHSP has very capable grant and financial management teams, as well as a public safety broadband program and project management team in place to successfully manage and conduct programmatic activities as proposed under SLIGP 2.0. NJOHSP's Grants Management Bureau (GMB) and Financial Office (FO) will provide the necessary support to the Interoperable Communications Bureau during the SLIGP 2.0 period of performance. The GMS/FO will fully comply with and adhere to NTIA grant reporting and compliance requirements described in section F.3 of the SLIGP 2.0 Notice of Funding Opportunity. The Grants Management Bureau (GMB) serves as the New Jersey's State Administrative Agency (SAA) for the Federal Emergency Management Agency's preparedness grant programs, responsible for administering over \$100 million in active federal grant funding. The GMB/FO is currently supporting the ICB for its FY2017 Public Safety Innovation Accelerator Grant Program award from the National Institute of Science and Technology. The GMS/FO is also supporting the ICB for the current SLIGP funding that was subgranted to NJOHSP from the State Office of Information Technology.

NJOHSP's Interoperable Communications Bureau team has significant public safety broadband program and project management experience as well as technical, planning and policy experience. Additionally, the ICB is one of only five (5) Nationwide Public Safety Broadband Network "Early Builders" in the nation by virtue of its JerseyNet proof of concept project. As noted above, NJOHSP's Director of Policy and Planning serves as New Jersey's SPOC due to his extensive policy and technical knowledge and experience in public safety broadband efforts at the national and state level. The ICB's contractor engagement team, Mission Critical Partners, is one of the nation's leading public safety communication consulting firms, bringing more than 30 years of experience in public safety communications and planning support to the ICB. The comprehensive knowledge, experience, and expertise of the entire NJOHSP enterprise will enable it to successfully implement all aspects of the State and Local Implementation Grant Program 2.0.

V. High-level staffing plan

This section details a high-level staffing plan of individuals who will be responsible for fulfilling programmatic and grant management requirements.

The following members of NJOHSP's Interoperable Communications Bureau will be fulfilling SLIGP 2.0 programmatic duties:
