Narrative description for each activity reported in Question 11 for this quarter; any challenges or obstacles encountered and mitigation strategies you have employed; planned major activities for the next quarter; and any additional of Further Identification of Potential Public Safety Users: Held a video conference with our new FirstNet Authority Regional Lead (FNA moved some people around) and SD AT&T/FirstNet Consultant. FirstNet Authority worked up բռոլուկի թակվեցը and a Blogs about Oglala Sioux Trib and Pennington County Sheriff's Office (Black Hills area). We posted them to our social media accounts. Video: https://youtu.be/ZQcqmniE9mM, https://youtu.be/OmEHV3LTd00 Blog: https://www.firstnet.com/community/blogs/pennington-county-joins-firstnet.html, https://www.firstnet.com/community/blogs/oglala-sioux-tribe-using-firstnet.html Plans for Emergency Communications Technology Transitions: We continue our monthly cadence of the broadband subcommittee meetings to discuss current technology topics specific to broadband (mobile & wired) usage for public safety in South Dakota, ideally looking at interoperability and convergence with LMR. The subcommittee members are incorporating tools now beyond proof of concept and ultimately adding the capabilities of these tools to other communication plans. We will continue to monitor this work. Had a video conference with border state Minnesota to discuss a cross-border interoperability proof-of-concept, with mobile broadband, between our two states. Identified and Planned to Transition PS Apps & Databases: Virtual (Skype) meeting of the Broadband Sub-committee for SDPSCC Council reviewed information about various applications. Discussion on how to integrate the different systems used across our state. Committee member, Pennington Co. Emergency Manager (and team) discussed with us how they are working to integrate Bridge4PS locally including the POTUS visit to Mt. Rushmore Independence Day fireworks. Attended various webinars and reviewed articles on Public Safety Communications. As a member of the Information Sharing Framework Task Force (ISFTF) we reviewed the SAFECOM NCSWIC-ISF document that is an Approach for Developing an Interoperable Information Sharing Framework. Identify Ongoing Coverage Gaps: Every meeting we attend and every stakeholder we visit with we discuss coverage gaps, and lack or impaired wireless service issues they have in their area. We discuss coverage issues in each weekly meeting with AT&T. FirstNet is providing some cell boosters to a known coverage gap area for law enforcement to test. Connected AT&T with SD Dept. of Transportation so FirstNet could again park their Sat Colt in the DOT secured yard in Sturgis for the Sturgis Rally. Governor Kristi Noem announced that 14 projects have been awarded grants to fund broadband projects to better connect unserved and underserved areas across South Dakota. USDA also announced investing along with SDN Communications a program to help install more fiber in the Black Hills. This investment will be in areas well known for being underserved or not served at all. These broadband projects will only improve public safety broadband communications and some of these areas will include backhaul for FirstNet towers. Any challenges or obstacles encountered and mitigation strategies you have employed: Ongoing issue with weekly dialogue is the outage reporting process, which at this point is not specific or helpful in determining service levels in South Dakota. We hear of outages before they are even reported in the FirstNet Central website. Planned major activities for the next quarter: We will continue to search for interoperable applications (or system) to be used across our state. Continue the Public Safety Mobile Broadband subcommittee work. We will continue to attend (as possible during COVID-19) FirstNet-requested public safety stakeholder outreach meetings focused on various topics. Any additional project milestones or information: Submitted 9th Quarter SLIGP2.0 Performance Progress Report and the Federal Financial Report. Broadband subcommittee members have utilized the Bridge4PS secured chat platform application in various ways that are demonstrating proof of concept for a nationwide interoperable tool for all first responders. SD has gone beyond the proof of concept and are edging on the use for mission critical collaboration. Other allowable activities performed this quarter include: Quarterly call with our SLIGP2.0 NTIA Program Manager. Our governance council (SD Public Safety Communications Council) met (6/25/20) via video conference with discussion from the broadband committee and our FirstNet state consultant gave a report about the towers/sites being built. Hopefully we'll see some online 3rd or 4th quarter of this year. Attended an educational webinar update on FirstNet in the State of Nebraska that provided good information on FirstNet improvements on the border of our states. Listened to the FirstNet Authority combined board and committee meeting (6/17/20). Held multiple conference calls with FirstNet Authority Regional Lead. Communicated with the communication planners for the Mt. Rushmore Independence Day fireworks to identify any broadband implications, or possible shared resources. FirstNet will have a Sat Colt available for the additional usage expected. Continue to monitor the press and social media for FirstNet knowledge and other LMR/LTE mobile broadband information. We continue collaboration with other neighboring states to discuss FirstNet experiences. Also have conference calls with AT&T (weekly) and FirstNet Authority. Attend (in person/online) various meetings webinars and inform our stakeholders through social media as appropriate.
