

**Suspension of kids.us domain and transition plan**

- 1. NTIA has determined that the kids.us domain is not serving its intended purpose as per the Dot Kids Act [Dot Kids Implementation and Efficiency Act of 2002, Pub. L. No. 107-317, 116 Stat. 2766 (Dec. 4, 2002), codified at 47 U.S.C. § 941.]. The kids.us domain is hereby suspended, as follows, until such time as NTIA determines that the domain can be operated as intended. The date of suspension will be 30 days from the date of this amendment.**
- 2. Prior to the date of suspension, Neustar will notify the kids.us accredited registrars that it will cease accepting new registrations and/or any renewals.**
- 3. Prior to the date of suspension, Neustar will modify the kids.us homepage to provide information on the suspension of the kids.us domain. This page will remain available during the course of the current contract period including option periods should any be granted.**
- 4. Prior to the date of suspension, Neustar will ensure that all current kids.us registrants are advised that NTIA has suspended the kids.us domain and that names expiring will not be renewed after the date of suspension.**
- 5. Prior to the date of suspension, Neustar will ask that each kids.us registrant, which currently has an active kids.us website(s), to voluntarily suspend use of its kids.us domain, removing all content, within 90 days of this suspension. Should a registrant not voluntarily suspend use of its domain name within the 90 days, Neustar will notify the registrant that it will no longer waive the content management fee of \$250 per year on a prorated monthly basis, per domain name. Neustar will continue to allow for the resolution of any site for which permission is not granted and will continue to monitor the website as required by the contract.**
- 6. As of the date of suspension, Neustar will no longer accept any new applications for content review in the kids.us domain. Neustar will continue to perform its content review function on all live kids.us websites for as long as those sites remain live in accordance with the provisions below and as required by the contract.**
- 7. Within 30 days after the suspension, Neustar will reserve all currently registered kids.us names. The reserved names, together with their WHOIS information, will be reserved until such time that the kids.us program can be reestablished. Should kids.us be reestablished, the person/entity currently listed as the registrant will have the first right to re-register that domain name. The names will be reserved without charge to the current registrant. Neustar will ensure that the registrant is notified of this action as noted above in item 4.**
- 8. Neustar will work with the registrars to reimburse the registrant for fees that have already been collected on kids.us names that expire in 2013 and beyond. Neustar will pay the registrar \$50 per name for these names and will strongly encourage the registrar to reimburse the domain name holder for any fees which have already been collected. Regardless of expiration date, within 365 days from date of suspension Neustar will ensure that all kids.us names will be removed from the .us zone.**

**All other terms and conditions remain unchanged.**
