Their locations are Delaware Nation Headquarters Complex, Delaware Nation Cultural Preservation office, Delaware Nation Housing Office, Delaware Nation Early Childhood Learning Center (ECLC) all in Anadarko, OK, Casino Oklahoma located in Hinton, OK and Delaware Nation Vocational Rehabilitation office in Oklahoma City. Due to external factors, we are unable to get the other 7th site at our Delaware Nation Vocational Rehabilitation office in Anadarko operational at this time.</p>

Telemedicine subscriptions have been initiated for 122 households. Laptop kits have been distributed to 832 households. Free public wi-fi networks have been implemented at 6 Delaware Nation locations</p>

The payments to Shot Rok, LLC and American Telecom and Technology for the Wi-Fi network installation and service was completed prior to April 30, 2023. The payments for contract service and corresponding medical device kits were made prior to April 2023 to Telemedicine.com</p>			
4	<p>Please describe how the recipient and subrecipient (if applicable) expended the funds. (600 words or less)</p> <p>Delaware Nation provided an additional 57 households with Internet Subsidy Assistance since May 1, 2023 thru April 30, 2024.</p>

Delaware Nation continued providing home internet subsidy assistance to allow affordable internet and prevention of disconnection of internet service. Delaware Nation continued promoting and providing telehealth subscriptions and devices.</p>
