- The remaining 58% of reporting agencies use their own agency specific forms.
- The majority of agencies post the appropriate application forms on their websites.

Question 9 Process Change Implementation & Question 10 Process Change Solicitation

- Process changes are made through established channels with multiple levels of review which generally culminate with leadership approval.
- 58% of agencies reported;
 - that changes to the permitting process are communicated via websites.
 - they utilize public comment periods/meet with impacted stakeholders before and after implementing process changes (NTIA also provides resources).





Question 11: Resources for Stakeholders

- All agencies are utilizing web sites to host information regarding permitting processes.
- Agencies regularly conduct calls with industry, participate in industry days, or assign program managers to coordinate with industry representatives.
- Two agencies reported that they provide training for industry representatives that cover correct completion of applications and navigating the permitting process.





Question 12: Employee Training

- 83% of responding agencies provide initial training to staff regarding the permitting process.
- Two agencies reported that their training has refresher requirements.
- Training modes include webinars, web-based training (self-paced), and in person training.
- Two agencies reported they provide training for stakeholders/allow stakeholders to sit in on staff training.

Permit Reporting Requirement

• EO 13821 - Within 180 days of the date of this order, and on a quarterly basis thereafter, all Federal property managing agencies shall report to the...the number of Common Form Applications received, the percentage approved, the percentage rejected, the basis for any rejection, and the number of working days each application was pending before being approved or rejected. Each report shall include the number of applications received, approved, and rejected within the preceding quarter.

Question 15: Process Delays

- Common process delays include:
 - Environmental due diligence (NEPA and other regulations)
 - Spectrum analysis
 - High workloads for staff
 - Land appraisals/determination of "Fair Market Value"
 - Incomplete applications
 - Communication with industry during contract negotiations
 - Assessment of mission/site compatibility





Question 16: Work Distribution

- 83% of agencies perform permitting functions at field and regional sites.
- USAF reported that 25-50% of permitting functions at HQ.
- FCC reported all permitting functions occurred at HQ.

Question 19: Tracking Mechanisms

- 67% of responding agencies track applications through a single point of contact.
- 17% of agencies currently utilize a centralized database to track processing of applications.
- 17% of agencies reported no specific tracking mechanism.





Question 20: Fee Policies & Question 21: Process Fees

- DOD agencies utilize Title 10 U.S.C to justify fee collections.
- Civilian agencies utilize a variety of laws and regulations.
- In general, fee regulations require that the permitting agency receive "Fair Market Value" for land use.
- 92% of agencies reported they collect fees as part of their permitting process.





Question 21a: Fee Use & Question 21b: Stakeholders Involved

- Agencies reported that fees are collected for:
 - Cost Recovery
 - Rent
- Most agencies are not able to retain rent, which is sent to the U.S. Treasury.
- Land management and DOD agencies collect fees through their local and regional offices.





Question 22: Incomplete Application Metrics

 92% of responding agencies reported that they did not maintain data regarding incomplete applications.





Question 23: Permitting Process Challenges

- Land Management agencies face staffing constraints (i.e. maintaining a staff of subject matter experts to fulfill agency specific missions) which slows the processing of applications.
- BLM noted that rent collected from Communications sites goes to the Treasury. Congress returns \$2 million dollars through appropriations, this amount has not changed in 23 years, while rentals collected have increased 500%, demonstrating an increased workload.
- DOI agencies noted they are required to receive fair market value for managed lands. Specifically DOI agencies must get the DOI Appraisal and Valuation Services Office (AVSO) to perform appraisals which may delay the process 3 – 12 months.
- Agencies are unable to retain/hire qualified communications site personnel.
- Environmental, Historical, and Spectrum review processes are a persistent challenge.
- Inability to asses entire projects under NEPA, as NEPA reviews are site by site.





Question 24: Existing Streamlining Efforts

- All agencies reported that they have existing streamlining efforts, including participation in the BIWG and agency specific efforts.
- NTIA is collecting greater depth of information required for the milestone report due to the Office of Science and Technology Policy (OSTP).



Data Call Findings

- Agencies perform permitting functions at the local/regional level.
 - USAF and FCC were the only agencies to report that some of their permitting work was done at headquarters.
- Permitting processes include a pre-application meeting to discuss applicant's proposed property use. This is a common practice across all agencies.



Next Steps

- How frequently are "Fair Market Values" updated or managed lands assessed?
- How frequently must DOI agencies have DOI/AVSO review application sites? Can we contact DOI/AVSO?
- Is it possible to add "Administration Fees" to rent to assist agencies in providing funding for qualified communications staff?
- How do agencies explain the application process to applicants?





Recommendations


- Review the land appraisal process and rental fee schedules from all agencies through a Fees Sub-Working group to:
 - Examine fee remittance policies for all agencies, specifically inquire if agencies can remit rent payments
 - Develop a uniform definition of "fair market value"
- Explore standardization of definitions of facility types to enhance communication between agencies.
- Improve data collection regarding the EO 13821 permit processing time reporting requirement. (Question 13a)






USAF Process








Leasing worst case 16 month process...best case, 13 months




Navy Process








DOI/NPS Process

NPS ROW Permitting Process









<u>USDA Forest Service</u> Steps in Special Uses Proposals, Application, and Authorization Process,






